ZDHC Solutions Roadshow 2023 ZDHC解決方案巡迴研討會2023

Since 2011, ZDHC has developed a set of guidelines and platforms for chemical management in the textile, apparel and footwear industry, providing solutions to improve chemical management and eliminate the use of hazardous chemicals. To implement them, it is important for all parties in the supply chain to strengthen understanding and have close collaboration. To support the supply chain to further implement the Roadmap to Zero (RtZ) Programme and get simple, efficient and one-stop necessary information and solutions, we will hold ZDHC Solution Roadshow in 2023.

自2011年以來，ZDHC為紡織服裝和鞋類行業的化學品管理提供了一套行之有效的指南和工具，為提升行業的化學品管理和消除有毒有害化學物質的使用提供了解決方案。在此過程中，供應鏈各方瞭解、緊密合作尤為重要。為支持供應鏈對零排放路線圖計畫的深度執行，簡單、高效、一站式地獲取必要資訊和解決方案，我們將於2023年舉辦巡迴研討會。

Seminars with ZDHC approved service providers 與ZDHC認可的服務提供者聯合開展研討會

ZDHC approved service providers include ZDHC accepted MRSL Conformance Indicators, ZDHC approved InCheck service providers, ZDHC Accepted Laboratories for ZDHC Wastewater Guidelines and ZDHC Approved Training Providers. They provide support on input management, process management and output management during RtZ Implementation. In 2023, we will support service providers in East Asia to conduct many online and offline workshops in different languages, and fully support supply chains to implement the RtZ Programme.

Innovation: DMFa Phase Out Innovation創新: DMFa替代

With more than 5 years of efforts, the DMFa Phase Out Project will move from pilot to scale up. The year 2023 will be a more breakthrough year for water-based and solvent-free PU. We will work with the world's leading water-based and solvent-free chemical manufacturers, PU manufacturers and ZDHC brands to interact and explore a comprehensive DMFa Phase Out Journey.

5年多的努力，DMFa替代專案從試點走向了全面推進。2023年，將是水性和無溶劑合成革更具突破的一年，我們將聯合全球領先的水性和無溶劑化學品生產商，合成革生產商與ZDHC品牌互動，探索DMFa的全面替代。

Engagement with Chemical industry 與化學品行業的深度溝通與合作

The input chemical management is the first and most important step in RtZ Programme Implementation. The world's major chemical manufacturers have joined ZDHC's textile and footwear safety chemical database ZDHC Gateway, which makes the information transparent and enables the supply chain to reach a more simple, efficient and convenient procurement and management of safety chemicals. Beyond that, how to support customers to create more accurate CIL, How to support customers to substitute chemicals are not MRSL conformant and how to support customers purchase more safer chemicals. We will hold series of seminars to discuss these topics and support the facilities to move towards Zero Discharge of Hazardous Chemicals.
